



## Expression of Interest (EOI) – WHSE Service Providers

Container Exchange (COEX) is responsible for managing Queensland’s Container Refund Scheme, Containers for Change, which aims to reduce litter and increase recycling by providing a 10-cent refund for each eligible beverage container returned. COEX is responsible for ensuring Workplace Health Safety and Environment (WHSE) compliance and ongoing performance across its entire network of operators consisting of Container Refund Points (CRPs) Logistics and Processors totalling approximately 370 sites.

COEX are seeking Expressions of Interest from suitably qualified organisations to be part of a Panel of WHSE Service Providers. WHSE Service Providers will provide WHSE services to COEX’s designated sites/regions (all within QLD). WHSE service providers will be required primarily to undertake audits of COEX identified network sites inclusive of logistics, processors and CRPs within the requested timeframe.

All applicants will need to have formal WHSE practitioner qualifications/accreditations in Integrated Management Systems Lead Auditor, and an established track record in delivering WHSE audit services across a large number of geographically disbursed locations.
