WHSE update: Network Compliance Program nearly complete

We'd like to thank you for your support of our 2024 WHSE Network Compliance Program. Since June, we've conducted more than 300 site assessments, achieving a compliance rating of 92% This result is a testament to the efforts of our operators.

Out of the 1200+ identified actions, approximately 10% have already been closed out. Common themes include electrical/switchboards, psychosocial and plant risks. We appreciate you closing out your actions within the required timeframes.

Celebrating success with Mackay operators

Our board and executive leadership team recently met with local operators in Mackay, including Mackay Recycling, Return-It Paget, Anything Environmental Paget and Recycle Well Sarina.

The visit allowed us to hear first-hand experiences from our operator partners as well as celebrate the milestone of more than 400 million containers returned in the Mackay region. Ensuring container deposit systems are used correctly

To prevent ineligible containers from entering our network, please remember to ensure proper use of automatic redemption terminal machines (ART).

It's important that staff supervise these machines closely, inspect containers visually and ensure only eligible containers are deposited before starting the machine. ART machines should never run unattended.

Please speak with your team to make sure they are aware of their obligations in operating these machines in line with the Container Deposit System Manual and are not caught up in other tasks that prevent them from supervising these machines.

Working with schools to increase recycling efforts

Meet operator team Andrew Lambert and Julie Farrelly from Browns Plains Bottles and Cans. Andrew and Julie are passionate about promoting recycling, engaging schools and getting young people involved in the circular economy.

They have collaborated with Marsden State High School, resulting in more than 100,000 containers recycled and a 12.6% increase in the past year. The Browns Plains Bottles and Cans team also work closely with several schools in the area to amplify their recycling efforts.

Additionally, they encourage customers to drop off aluminium can ring pulls. The money raised through recycling the ring pulls is matched by Browns Plains Bottles and Cans and used to purchase wheelchairs for local residents in need. Well done, Andrew, Julie and their team!
