## WHSE update: Network Compliance program

Thank you to those of you who closed your action items from the 2024 WHSE network compliance program.

Of the 1,405 actions raised:

- 1210 are closed
- 60 are in progress
- 135 are yet to commence

### Container Collection Agreement compliance and IT disaster recovery planning made easy

We've made it easier to understand the compliance and reporting requirements under your CCA by creating a new CCA guide. This guide includes useful information such as weekly and monthly requirements to help you plan your reporting and claim submissions. Find it in our Operator Hub <u>here</u>.

### IT Disaster Recovery Plan

An IT Disaster Recovery Plan (ITDRP) is important in identifying potential risks to IT platforms, infrastructure and the POS system to ensure vulnerabilities are addressed to minimise the possibility of outages. To support operators in the development of their ITDRP, COEX has created a template which can be found in our Operator Hub <u>here</u>.

If you haven't done so already, please use the template to provide COEX with your ITDRP to ensure compliance with the CCA.

#### What happens to materials once collected?

Customer trust in the recycling outcomes of Containers for Change is an important factor in keeping collection volumes growing.

There are a range of useful resources available in our <u>Brand Hub</u> to help you educate your customers on the journey of materials once they are collected from your CRP. You can also watch our YouTube video <u>here</u> on the journey containers make once deposited.



#### **Ineligible containers**

Maintaining scheme integrity is critical and means ensuring only eligible containers are returned.

Here are some ways you can help:

- Return ineligible containers to customers, explaining why they have been returned and advise them to use their yellow top bin.
- Record ineligibles in POS to prevent payment disputes and to gather valuable data.
- Watch for large quantities of the same container, such as those discarded by manufacturers due to defects (e.g., cans with no tops) or containers deliberately punctured and never sold.
- If using counting machines, return ineligibles and swap them for uncounted eligibles.
- Train staff regularly and display examples of common ineligibles on-site.
