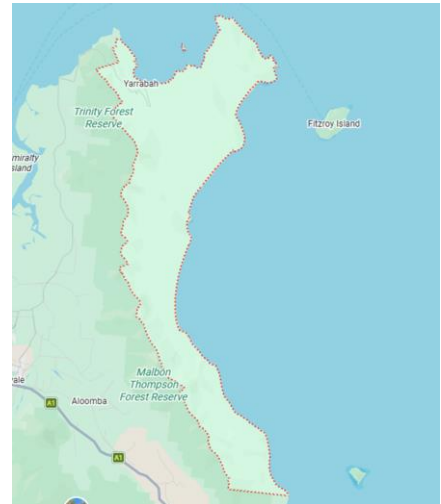

Container Exchange (COEX) in collaboration with Yarrabah Aboriginal Shire Council is excited to present an Expression of Interest opportunity in Yarrabah, a First Nations community and coastal town in Far North QLD, approximately 60km from Cairns. We are inviting current operators interested in servicing the area, with COEX to provide 1 x COEX-owned two chute bag drop, alongside an additional 3c service fee for each container collected in Yarrabah.

COEX is seeking current operators with strong business acumen to operate CRPs under the trusted Containers for Change brand. You will deliver customer-focused solutions that boost participation in container recycling by making it easy and convenient to return. Our goal is to expand our reach across the Yarrabah and surrounding area establishing new, conveniently located sites that serve the community.

How to apply

For your application to progress, you must meet the following requirements:

- You must possess a valid Australian Business Number (ABN)
- All owners / directors must be solvent and not subject to any form of bankruptcy
- An existing operator: 100% current contract compliance with all relevant safety audit actions closed out as appropriate.

Your application must include:

- Draft Traffic Management Plans (TMP);
- A branding mock-up of the proposed sites;
- Confirmation of the current zoning of the site, or steps required for the correct zoning; and
- Estimated timelines for mobilisation.

In addition, COEX will look favourably to the following additional criteria:

- Positive customer experience, including support services
- Customer accessibility
- Proposed engagement with social enterprise and community

Background

Container Exchange (COEX) is a not-for-profit organisation appointed by the Queensland government to manage and grow the state's container refund scheme – Containers for Change. Containers for Change was launched on 1 November 2018 giving individuals, charities, community groups and businesses 10-cent refunds for returning eligible containers.

We work with our operators and business partners to achieve our vision that no container goes to waste, ensuring the positive economic, social and environmental benefits of the scheme are shared with all Queenslanders.

Container refund points

Container refund points (CRP) are locations where customers return eligible containers for 10-cent refunds. They commonly include self-serve or drive-through depots, reverse vending machines (RVMs) in depot or retail precincts, shopfronts, bag drops, pop-up services and home collection services. CRP operators might be commercial or social enterprises, community groups or not-for-profit organisations. As a CRP operator, you play an integral role within Containers for Change. Your site/s would provide improved refund point accessibility to the local community and a positive experience for customers when they return their eligible containers.

CRP operators make a difference by facilitating recycling and fundraising opportunities in their local communities, helping keep containers out of landfill and ensure they can be used to grow the circular economy here and overseas.

If you are a skilled business operator looking to make a tangible difference, this is your chance to work with Containers for Change and share in the benefits of a scheme that has seen more than 10 billion containers returned, paying out more than \$1 billion to Queenslanders.
